

**MINUTES OF THE PUBLIC HEARING ON PROPOSED BUDGET AND SPECIAL VILLAGE BOARD MEETING NOVEMBER 27, 2017**

The public hearing on the Village of Biron proposed 2018 budget was called to order by President Jon Evenson on November 27, 2017 at 6:30 p.m. The proposed budget was properly published and posted as required by State Statutes.

**PROPOSED BUDGET:** The proposed budget for 2018 was presented and reviewed. **Expenses:** General Government - \$259,448.00, Public Safety - \$196,050.00, Public Works - \$446,379.00, Health & Human Services - \$1,550.00, Culture, Recreation and Education - \$36,200.00, Conservation and Development - \$1,000.00, Debt Service - \$70,000.00, Miscellaneous - \$2,000.00; for total expenses of \$1,012,627.00. **Revenues:** Property Tax Levy - \$752,208.00 Other Taxes - \$110,000.00, Intergovernmental Revenues - \$123,019.00 Licenses and Permits - \$13,900.00, Miscellaneous - \$13,500.00; for total revenues of \$1,012,627.00. The assessed value of the Village is \$93,602,800.00.

**ADOPT WATER UTILITY BUDGET:** **Motion** by Walker, second Siegler to approve the Water Utility budget of \$407,396.08 as presented. M.C.
