

**MINUTES OF THE PUBLIC HEARING ON PROPOSED BUDGET AND SPECIAL VILLAGE BOARD MEETING NOVEMBER 30, 2015**

The public hearing on the Village of Biron proposed 2016 budget was called to order by Trustee June Siegler on Monday, November 30, 2015 at 6:00 p.m. The proposed budget was properly published and posted as required by State Statutes.

**PRESENT:** June Siegler, Susan Carlson, Bob Walker, Tammy Steward, Dan Muleski, Mark Honkomp. Also present were Jon Trautman and Amber Danielski, representing Schenck SC.

**PROPOSED BUDGET:** The proposed budget for 2016 was presented and reviewed. Expenses: General Government - \$243,350.00, Public Safety - \$188,850.00, Public Works - \$440,617.00, Health & Human Services - \$1,500.00, Culture, Recreation and Education - \$30,500.00, Conservation and Development - \$1,000.00, Debt Service - \$70,000, Miscellaneous - \$2,000.00 for total expenses of \$977,817.00. Revenues: Property Tax Levy - \$742,464.00, Other Taxes - \$76,000.00, Intergovernmental Revenues - \$138,803.00, Licenses and Permits - \$9,500.00, Miscellaneous - \$11,050.00 for total revenues of \$977,817.00. The assessed value of the Village is \$96,741,700.

*Note:* President Jon Evenson arrived at 6:10 and took over to run the meeting.

**DISCUSSION:** Discussion and questions were voiced on the budget.

**ADJOURN:** **Motion** Walker, seconded Muleski to close the public hearing at 6:15 p.m. M.C.

**ADOPT WASTE WATER BUDGET:** **Motion** Muleski, second Walker to approve the Waste Water budget of \$315,365.00 as presented. MC.

**ADOPT WATER UTILITY BUDGET:** **Motion** by Walker, second Carlson to approve the Water budget of \$180,300.00 as presented. M.C.

**ADJOURN – Motion** Muleski, second Carlson to adjourn the November 30, 2016 Special Board Meeting at 6:45 p.m. M.C.
